1. Craigcrook mortification registered in Scotland Charity No SC001648 ("we" or "us") with registered office at the Signet Library, Parliament Square, Edinburgh EH1 1RF

#### **PRIVACY NOTICE**

- 2. Craigcrook Mortification is a controller of information which either directly or indirectly can be used to personally identify you ("Personal Information"). A non-exhaustive list of the type of Personal Information that we may collect about you:
  - name;
  - email address;
  - date of birth;
  - address;
  - landline and mobile telephone numbers;
  - marital status;
  - financial status (including salary, savings and income sources); and
  - facts or opinion relevant to your application.
- 3. This Privacy Notice:
  - a. describes how we collect, use and otherwise handle the Personal Information that you provide, make available to us or that we source;
  - b. explains the rights that you have in relation to this Personal Information.
- 4. Please feel free to contact the administrators if you do not understand anything contained in this Privacy Notice. Their contact details are available below.

### HOW WE COLLECT PERSONAL INFORMATION

- 5. Personal Information we control and process will typically be collected through direct interaction with you, from publicly available sources, and from third parties in the course of considering your application:
  - a. direct interaction: you may give us Personal Information by filling in forms or by corresponding with us by post, phone, email or otherwise. We might need to ask you for and use information which is of a sensitive nature, for example information about your health and finances. explains the rights that you have in relation to this Personal Information.
  - b. **public databases:** we may undertake searches in connection with you that reveal Personal Information. For example, we might undertake general searches to collate information in connection with a matter you have brought to us where necessary.



c. **third parties:** in some circumstances third parties may give us Personal Information. For example, if we were to contact the local council on your behalf.

### HOW WE USE PERSONAL INFORMATION

- 6. We will only use your information in connection with your interests and our legitimate interests as a grant maker. The Personal information we hold is processed on the basis of legitimate interest.
- 7. When relying on legitimate interest we will conduct balancing tests to ensure that:
  - a. the interest is legitimate;
  - b. that processing of data is necessary to the identified interest; and
  - c. the pursuit of the interest will not negatively impact you.

### HOW WE PROTECT YOUR PERSONAL INFORMATION

8. We employ appropriate security measures to help protect your Personal Information and guard against access by unauthorised persons. Information storage is on secure computers and cloud services and we limit access to your Personal Information to those who need to know. This is limited to Craigcrook Mortification's administrators, The WS Society and staff under their employment and Craigcrook Mortifications applications subcommittee (comprising three trustees). These parties are subject to a duty of confidentiality. We undergo periodic reviews of our security policies and procedures to ensure that our systems are secure and protected.

### YOUR RIGHTS IN CONNECTION WITH YOUR PERSONAL INFORMATION

9. Your various rights, explained below, are not absolute and each is subject to certain exceptions or qualifications. We will grant your request only to the extent that it follows from our assessment of your request that we are allowed and required to do so under data protection laws. Nothing in this Privacy Notice is intended to provide you with rights beyond or in addition to your rights as a data subject under data protection laws. Your rights:

Right	Meaning
The right to be informed	You have the right to be provided with clear, transparent and easily understandable information about how we use your Personal Information and your rights. This is why we are providing you with the information in this Privacy Notice.
The right of access	You have the right to obtain a copy of your Personal Information (if we are processing it), and certain other information about how it is used. This is so you are aware and can check that we are using your information in accordance with data protection law.  We can refuse to provide information where to do so may reveal Personal Information about another person or would
	otherwise negatively impact another person's rights.
The right to rectification	You can ask us to take reasonable measures to correct your Personal Information if it is inaccurate or incomplete. For example, if we have the wrong name, date of birth or address for you.



The right to erasure	This is also known as 'the right to be forgotten'. In simple
	terms this enables you to request the deletion or removal of
	your Personal Information where there is no compelling
	reason for us to keep using it or its use is unlawful.
The right to restrict processing	You have rights to 'block' or suppress further use of your
The right of restrict processing	Personal Information when we are assessing a request for
	rectification or as an alternative to erasure. When processing
	is restricted, we can still store your Personal Information,
	but may not use it further. We keep lists of people who have
	asked for further use of their Personal Information to be
	'blocked' to make sure the restriction is respected in future.
	You have rights to obtain and reuse certain Personal
The right to data portability	Information for your own purposes across different

The right to object	You have the right to object to certain types of processing, on
	grounds relating to your particular situation, at any time
	insofar as that processing takes place for the purposes of
	legitimate interests pursued by us or by a third party. We will
	be allowed to continue to process your Personal Information if
	we can demonstrate "compelling legitimate grounds for the
	processing which override your interests, rights and freedoms" or
	we need this for the consideration of your application.

The right to complain	If you are dissatisfied, you have the right to complain to the
The light to complain	Information Commissioner's Office (ICO) about our
